Axon and Safariland have also entered into a long-term strategic partnership with Safariland becoming the preferred holster supplier for Axon's TASER Conducted Electric Weapon (CEW).

Axon will begin servicing those customers immediately and looks forward to partnering with them to better understand how Axon and VIEVU can best serve their needs moving forward.

The terms of the deal include cash, stock and stock earn out. The majority of VIEVU's employees are based in Seattle and are expected to be integrated into Axon's Seattle office.
